- 3. 17 Dec: High Shoals Falls project in conjunction with David Kuykendall of the FS. All meeting/orientation times have now changed to 0845 with departure now at 0900.

Trail Maintenance Report By John Quinlan

Yesterday, Thursday, 19 Nov 09, dawned a beautiful clearing day for a great trip by seven hardy MHH volunteers for what promised to be a heavy day of chain saw cutting. We met in Hiawassee and then drove to Coleman River (A beautiful easy hike with roaring water-good for children though watch for the slippery bridge crossings! East of Hiawassee). We (seven of us) were well equipped for what we anticipated encountering. We encountered many trees (estimate 12-15) blown across the path rendering it near impassable. We used three chainsaws and made relatively short work of the task. There were a goodly number of trees requiring multiple cuts. All were removed from the trail. There was also some minor brush clearing, primarily using loppers. Dave Richardson led off with three helpers (Bob Stone, Don Chesebro, and Jake Ehrhart) and went to the far end and worked back toward the second group (Tom Shope, Jim Morgan, and John Quinlan). We had a great time with superlative views and enjoyed lunch watch the roaring river. As has become our norm, all worked hard and I am always so pleased by what a great attitude each person displayed. As a result this trail is opened back up but regrettably not really safe for novices due to the slippery partially broken bridges.

In my opinion, shared by the others on the team, there were problems with the safety of the three bridges. The first and third were both missing hand rails and the supporting 4X4s were rotted. The middle one was canted, or sloped downward toward the river and VERY slick with dampness and mildew. Note: None of us fell fortunately). The is a very real safety issue compounded by the very weak hand rail that is loose and not likely to support someone falling against it.

We can solve many of these the problems . The second bridge is probably beyond our capability to rectify alone. We need FS assistance for which I have communicated with them. In the interim I suggested to the FS that signs be erected just before each bridge warning of the slipperiness, and, especially for the second one, if there were some sort of gritty surface material that could be applied to the surface of the bridge decking. This then likely would require a thorough cleaning first.

Since the materials are especially large it'd be helpful if we could establish a rendezvous date/time with the FS for them to deliver said materials. That would greatly assist us in handling the transportation aspects of the long lumber.

Highway 64 Closed Forwarded by Richard Sullivan

The Tennessee Department of Transportation (TDOT) has closed Hwy. 64 on the east side of Boyd Gap due to the rockslide for at least 2 months.

This closes the whole Whitewater Center, Thunder Rock Campground, and all of the hiking trails at the Whitewater center and off Hwy. 64 area to residents. The feds have closed the center itself.

Gordon and I drove over to the Ocoee Whitewater center today, and found out that 64 is now open up to Ocoee #3, across from the Lead Pond trail. A few weeks ago, you could not go much beyond the Brush Creek trail, which is a good ways from the Whitewater center. I talked with a volunteer in the white water center and she said that most of the time, 64 will remain open up to #3, with the exception being on days when they decide to do some blasting. It seems no one knows when that will be, including the people who work at the White water center, so there is a small risk that anyone who hikes over there will run into that scenario.

Your Comments Needed on Accessible Trails

The U.S. Access Board is asking for comments on their October 2009 "Draft Final Accessibility Guidelines for Outdoor Developed Areas" by December 18, 2009. These Guidelines will become final direction for accessibility on trails on Federal land. Once the Guidelines are finalized they will be the basis for future regulations which will apply to ALL new trails on local and State lands as well. It is critical that trail designers, contractors, and managers review these guidelines closely and comment on issues or concerns they see.

CONCERNS FOR TRAIL PLANNERS AND MANAGERS

Agencies and organizations have raised concerns about aspects of the Guidelines which seem vague and could cause problems with compliance. The Guidelines contain a number of changes from the 2007 "Notice of Proposed Rulemaking" (NPRM), which received over 600 comments.

Comparing the new **Guidelines** with the previous NPRM:

- Trails are required to comply with the accessibility requirements "to the maximum extent feasible." The term "feasible" is not defined, so there is no guidance on how much change to the trail environment is the maximum feasible.
- NPRM permitted exceptions where compliance would "substantially alter" the function or purpose of the facility or the setting. The new Guidelines change this to "fundamentally alter," a term both vague and absolute.
- NPRM allowed exceptions where "compliance would cause substantial harm to cultural, historic, religious, or significant natural features or characteristics." The Guidelines require designers to cite specific laws for any exception, which would result in more bureaucratic effort and a deterrent to building new trails.
- If it is decided that a new or altered trail will not comply with the guidelines, an unspecified Notification must be filed with the Access Board, which could become another burden to trail managers.
- In previous versions, guideposts helped trail managers document when following the guidelines was not "reasonable." These guideposts are now deleted, leaving managers' decisions legally reviewable based only on the judgment of the Access Board.


